After calling the meeting to order, President Kaufman led the Pledge of Allegiance. The Clerk called the roll, with the following members present: Blunier, Leitch, Leman, Menold, Newman, Parrott – 6.

PUBLIC HEARING – None.

PRESENTATIONS AND SPECIAL REPORTS – Trustee Leitch presented a couple reports and updates. The first topic was an update on the natural gas cost issues that have arisen recently around the extremely increased purchase prices. He read a statement and along with DPW Loudermilk gave an overview of the situation and factors that have played into it as well as thanking the citizens and local businesses for doing their part to reduce usage as much as possible during this time. The second topic he spoke about was an update on the Economic Sustainability Grant Program. The Illinois DCEO has been exploring the option of allowing the Village to reopen the grant program, but has not yet issued the specific rules the Village would need to follow. There is approximately \$223,000 that is leftover for these grants, but the Village is awaiting the DCEO rules before hopefully being able to reopen the grant program. Trustee Leitch and Administrator Smick spoke to details around this program as well as the appreciation of the grantees.
