## Village of Morton Electrical Contractor Certification Application

In order to apply for a permit to perform electrical work within the Village of Morton, an electrical contractor must first obtain an Electrical Contractor's Certification from the Village of Morton Zoning & Code Enforcement Department. Certifications are valid for one calendar year from January 1<sup>st</sup> – December 31<sup>st</sup>. The fee for a certification obtained after January 1<sup>st</sup> is not prorated. Electrical contractors will need to provide the following to obtain certification:

**1. Copy of your Electrical Contractor's License from one of the following communities:**

- Peoria, IL
- Bloomington, IL
- Springfield, IL
- Decatur, IL
- Pekin, IL
- Ottawa, IL
- Joliet, IL
- Any other Illinois testing community (pending verification by the Zoning & Code Enforcement Officer)

**2. A fee of \$100.00 payable by credit/debit card, check by phone or mailed (see above).**
