SUBMITTAL REQUIREMENTS & INFORMATION FOR A MANUFACTURED/MOBILE HOME PERMIT

Information on the requirements for mobile homes can be found in the Morton Municipal Code 10-5-7. The following must be met/provided for all new and replacement manufactured homes:

- A site plan must accompany the application and show the following items:
 - The manufactured home that includes the dimensions of the home
 - Setback distance to adjacent lots and the road
 - The driveway/parking and dimensions with setbacks

- Each site must provide a minimum of one (1) parking space that is constructed of either black top or concrete.

- Will there be any accessory buildings or structures included with the mobile home? If so, please include the size and location on the site plan

- Provide proposed setbacks to the boundary line of the area for the mobile home

- A minimum ten feet (10') setback to an adjacent boundary line or twenty feet (20') to an adjacent manufactured home must be met

- A certificate of elevation (if applicable)
