RESOLUTION NO. <u>04-24</u>

RESOLUTION RETIRING K-9 SERVICE ANIMAL "SHADOW" PURSUANT TO THE POLICE DOG RETIREMENT ACT

WHEREAS, the Police Dog Retirement Act (510 ILCS 82/1 et seq) provides that if a K-9 service animal is no longer fit for public service in the municipality, it must be offered by the municipal police department to the officer who had custody or control of the animal during its service; and

WHEREAS, the Village of Morton's K-9 service dog "Shadow" is no longer fit for public service, and the Village of Morton desires to retire the service dog; and

WHEREAS, the handler of the K-9 service dog "Shadow," Sergeant Mike Foster, has agreed to take ownership and custody of the service animal "Shadow" under the terms and conditions set forth in this Resolution.

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MORTON, Tazewell County, Illinois, as follows:

- 1. The recitals set forth in the preamble to this Resolution are hereby found to be true and correct and are incorporated herein by reference.
- 2. The Mayor and Board of Trustees for the Village of Morton hereby deem and declare service K-9 "Shadow" as no longer fit for public service, and do hereby retire "Shadow" as K-9 Officer for the Village of Morton Police Department.
- 3. The Village of Morton hereby transfers ownership and control of the service animal "Shadow" to Sergeant Mike Foster, effective upon passage of this

Resolution, subject to the terms and conditions of this ordinance. The Village of Morton agrees to reimburse Mike Foster for actual out of pocket expenses incurred for food and veterinary care provided to "Shadow." Except for that reimbursement authorized herein, in all other regards by accepting ownership of "Shadow," Sergeant Mike Foster forever absolves and releases the Village from any other reimbursement claim for the cost of caring for "Shadow."

BE IT FURTHER RESOLVED that this resolution shall be in full force and effect upon its passage and approval.
