RESOLUTION NO. 03-25

RESOLUTION REGARDING STAFFING MODEL FOR FULL-TIME FIRST SHIFT FIRE DEPARTMENT

WHEREAS, the Village of Morton Fire Department traditionally operates with the support of volunteers, especially for emergency response during fires and other crisis situations;

WHEREAS, a noticeable decline in volunteer availability during first shift hours has prompted the Village of Morton to consider alternative staffing solutions;

WHEREAS, the objective is to ensure reliable emergency response services through the employment of full-time firefighters to cover day shift hours from Monday to Friday;

WHEREAS, the Corporate Authorities, acknowledging this need, previously authorized the hiring of five full time day shift firefighters, and directed the Board of Fire and Police Commissioners to proceed with such rulemaking as may be required to facilitate hiring full time day shift firefighters; and

WHEREAS, the Board of Fire and Police Commissioners has approved amendments to its rules and regulations allowing the recruitment of dedicated full-time day shift firefighters;

WHEREAS, the Village of Morton has established a target of hiring five competent individuals for these full-time positions, reflecting the Village's commitment to enhanced public safety and operational efficiency;

AND WHEREAS, the Fire Chief has recommended a staffing model that balances the need for experienced personnel with the Village's fiscal and operational considerations;

NOW THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MORTON, Tazewell County, Illinois, that:

1. The standard work schedule for full-time firefighters will be Monday through Friday, from 7:00 AM to 5:00 PM.

- 2. Overtime compensation will be based on a 28-day cycle, with overtime pay triggered when work hours exceed 212 hours within this period.
- The full-time day shift at the Fire Department will consist of five full-time firefighters to maintain operational readiness.
- 4. Compensation for full-time day shift firefighters will be set at an hourly rate of \$25.58, resulting in an annual salary of \$66,504, calculated over a standard work year of 2,600 hours.
- 5. This resolution serves to transparently outline the terms of employment for potential full-time firefighter candidates, facilitating an informed decision-making process. However, this document does not constitute a permanent employment contract and may be subject to adjustments or overrides by subsequent administrative decisions or directives from the Fire Chief or the Corporate Authorities.

BE IT FURTHER RESOLVED that this resolution shall be in full force and effect upon its passage and approval.
